

**AN ORDINANCE ESTABLISHING A  
DNR GRANT FUND  
FOR THE TOWN OF WINAMAC, INDIANA**

Ordinance No.15 of 2019

**WHEREAS**, the Town Council of the Town of Winamac, Indiana (the “**Town Council**”), is responsible for the performance of various functions for the Town of Winamac (the “**Town**”); and

**WHEREAS**, the Town has been awarded a grant for One Hundred and Thirty-Two Thousand Dollars (\$132,000.00), from the Indiana Department of Natural Resources (DNR), for certain renovations and improvements to the Winamac Town Park (the “**Park**”); and

**WHEREAS**, the Town will be required to match a portion of this grant money with matching funds from the Town’s Recreation Fund and Gift Park Fund; and

**WHEREAS**, the Town is desirous of creating a separate fund for the receipt of all distributions by the Indiana DNR for renovations and improvements to the Winamac Town Park, as well as to receive transferred funds from the Town’s Recreation Fund and Gift Park Fund.

**NOW, THEREFORE, BE IT RESOLVED**, by the Town Council of the Town of Winamac, Indiana, that the following Ordinance Establishing a DNR Grant Fund for the Town of Winamac, Indiana, is hereby adopted as follows:

**Section I.**  
Establishment

1. **DNR Grant Fund.** Be it now resolved, that the Town Clerk-Treasurer is hereby authorized to create a new Fund for the receipt of the aforementioned funds from the Indiana DNR, as well as to transfer Sixty-Five Thousand Dollars (\$65,000.00) from the Town’s Recreation Fund (Fund #312), and Sixty-Seven Thousand Dollars (\$67,000.00) from the Town’s Gift Park Fund (Fund #316), as matching moneys. Said Fund shall be called the DNR Grant Fund (Fund #224).

2. **Non-Reverting.** The DNR Grant Fund shall be a perpetual fund, and expenditures can be made from the Fund only for those purposes as enumerated in this Ordinance.

3. **Authorized Use of Funds.** Moneys received, or transferred, shall be used for renovations to the Winamac Town Park, and for those other purposes expressly approved by the Town of Winamac Board of Parks and Recreation, provided they are consistent with the DNR regulations and guidelines for receipt of said funds.


**Section II.**  
Effective Date


1. **Effective Date.** The DNR Grant Fund shall be established as of the date of passage of this Ordinance, and shall be of perpetual existence, or until this Ordinance is duly repealed by the Town Council of the Town of Winamac.


