

**AN ORDINANCE ESTABLISHING A  
NEILBERT CEMETERY TRUST FUND AND AUTHORIZING  
THE TRANSFER OF CERTAIN FUNDS TO SAID FUND**

Ordinance No. 8 of 2019

**WHEREAS**, Fund #203, Motor Vehicle Highway (MVH) Restricted, currently contains certain funds attributable to the Neilbert Cemetery Trust; and

**WHEREAS**, the Town of Winamac (the "**Town**"), by and through its Town Council (the "**Town Council**") wishes to establish a new fund to transfer the current funds attributable to the Neilbert Cemetery Trust into, while still using Fund #203 for MVH Restricted funds, and all authorized uses tangential thereto.

**NOW, THEREFORE, BE IT RESOLVED**, by the Town Council of the Town of Winamac, Indiana, that the following Ordinance Establishing a Neilbert Cemetery Trust Fund and Authorizing the Transfer of Certain Funds to Said Fund, is adopted as follows:

**Section I.**

Establishment and Transfer

1. **Neilbert Cemetery Trust Fund.** Be it now resolved, that the Town Clerk-Treasurer is hereby authorized to create a new Fund for the receipt of the Three Hundred Thirty-Eight Dollars and Eighty-Seven Cents (\$338.87) attributable to the Neilbert Cemetery Trust, which currently is being held in Fund #203, Motor Vehicle Highway Restricted. Such fund shall be called Fund #210, the Neilbert Cemetery Trust Fund.

2. **Funds Transfer.** Pursuant to state law, and for the purpose of keeping funds segregated, the Town Clerk-Treasurer is further hereby authorized to transfer the Three Hundred Thirty-Eight Dollars and Eighty-Seven Cents (\$338.87) attributable to the Neilbert Cemetery Trust, and currently being held in Fund #203, Motor Vehicle Highway Restricted, to the newly created Fund #210, the Neilbert Cemetery Trust Fund.

3. **Authorized Use of Funds.** Authorized expenditures from the Neilbert Cemetery Trust Fund include costs of associated with the care, maintenance, and decoration of the graves of the James S. Neilbert, as all funds received by the Neilbert Cemetery Trust Fund were from the widow of James S. Neilbert, and not tax moneys.

**Section II.**


Effective Date

1. **Effective Date.** This Ordinance shall become effective upon its passage by the Town Council of the Town of Winamac, Indiana, at a regularly scheduled meeting open to the general public.


