

**AN ORDINANCE TRANSFERRING  
MOTOR VEHICLE HIGHWAY FUNDS TO THE  
COMMUNITY CROSSINGS MATCHING GRANT FUND  
FOR THE TOWN OF WINAMAC, INDIANA**

Ordinance No. 6 of 2020

**WHEREAS**, the Town Council of the Town of Winamac, Indiana (the “**Town Council**”), is responsible for the performance of various functions for the Town of Winamac (the “**Town**”); and

**WHEREAS**, the Town is desirous of transferring funds from Fund # 203: Motor Vehicle Highway, to Fund # 259: Community Crossing Matching Grant Fund, for the purposes of satisfying the Town’s matching portion of the Indiana Department of Transportation’s (INDOT) Matching Grant the Town was awarded.

**NOW, THEREFORE, BE IT ORDAINED** by the Town Council of the Town of Winamac, Indiana, that this Ordinance Transferring Motor Vehicle Highway Funds to the Community Crossings Matching Grant Fund for the Town of Winamac, Indiana, is hereby adopted as follows:

**SECTION I.**

Transfer

1. **Transfer.** The Town Clerk-Treasurer is hereby authorized, pursuant to this Ordinance, to transfer the amount the Town is required to match for the Community Crossings Grant award from INDOT, from Fund # 203: Motor Vehicle Highway, to Fund # 259: Community Crossing Matching Grant Fund.

- (a) The exact amount the Clerk-Treasurer is authorized to transfer has not yet been determined, but it shall not exceed Twenty-Five Percent (25%) of the winning bid amount from the winning bidder for the Town’s paving project, under the Community Crossing Grant.

**SECTION II.**

Effective Date

This Ordinance shall become effective immediately upon its passage, in a meeting that has been properly advertised, and open to the general public.


